#### 1. Description of Work

2.1. Financial bid of only those vendors will be opened whose technical bids will be found successful. Date and time of opening the financial bids will be informed later on.

#### 3. Scope of Work

The proposed work is procurement of the hardware which is divided into following **two** categories:

- I. Provision of Branded Laptops
- II. Provision of Branded Printer

Responding Organizations are allowed to bid for the both categories or any of the above mentioned category. Responding organizations are requested to clearly mention the category, they are bidding for, on the main envelop of technical and financial proposals. Evaluation will be done separately for each category. Competition Commission of Pakistan reserves right of awarding the tender for one or both items, after opening of financial proposals.

#### 4. Implementation & Payment Schedule

100% payment will be made after delivery of the laptops and printers on clarifications/acceptance of items by IS&T department of CCP.

#### **6** General Terms & Conditions

#### 6.1 Bid Security

A bid bond/ security, in the shape of a Bank Draft/Pay Order in the name of Competition Commission of Pakistan, equivalent to 5% of the total cost of bid should be submitted along with the tender. CCP reserves the right to forfeit the bid bond, if the information provided is not correct and is not according to the various formats provided in this document.

#### 6.2 Validity of the proposal

All proposal and price shall remain valid for a period of 90 days from the closing date of the submission of the proposal. However, the responding organization is encouraged to state a longer period of validity for the proposal. The firms operating from their residence should not participate in the tender if detected subsequently at any stage are liable to be rejected.

#### 6.3 Performance Bond upon execution of Contract/issuance of Supply Order

The successful vendor shall be required to deposit in the form of a Bank Guarantee, a Performance Bond upon execution of the contract issue, a sum equivalent to ten percent (10%) of the contract value. This Bank Guarantee shall be issued by a scheduled bank operating in Pakistan

#### 6.4 Maintenance and Support Service

Selected vendor will provide maintenance/support service, after expiry of warranty, for each product at a rate, which is not more than 10% of the initial purchase cost, if desired by CCP.

#### 6.5 Penalty Clause

The successful vendor shall be required to deliver the laptops and printers within the given time mentioned at 6.13. However if they fail to provide within the time, this office has right to confiscate the bid money.

#### 6.6 Currency

All currency in the proposal shall be quoted in Pakistan Rupees (PKR).

#### 6.7 Withholding Tax, Sales Tax and other Taxes

The responding organization is hereby informed that the CCP shall deduct tax at the rate prescribed under the tax laws of Pakistan, from all payments for the items supplied by any responding organization in response to supply order of CCP. The responding Organization will be responsible for all taxes on transactions and/or income, which may be levied by government. The tender should be accompanied by firms Sales Tax Registration Certificate and National Tax Number.

#### 6.8 Authorized Dealer

The responding organization should be authorized dealer, **FROM THE ORIGINAL MANUFACTURER** for the hardware and **FROM THE ORIGINAL MANUFACTURER** for licensed software in Pakistan. Original CDs of all licensed software should be provided.

#### 6.9 Ownership

The ownership of all products and services rendered under any contract arising as a result of this RFP, including any source code developed, will be the sole property of CCP, Government of Pakistan.

#### 6.10 Governing Law

This RFP shall be governed and construed in accordance with the laws of Pakistan. The Government of Pakistan and all responding organizations responding to this RFP shall submit in accordance the Law.

#### 6.11 Acceptance of Proposals

Financial Proposals of only technically qualified bidders will be opened. The decision of the Committee will be binding on all concerned and in no case will be challengeable at any forum. The CCP may reject all the bids or proposals at any time prior to acceptance of a bid or proposal under the provisions of Rule 33 (1) of the Public Procurement Rules, 2004.

#### 6.12 Acceptance Criteria

Lowest financial proposal which meets the following technical requirement;

- Compliance to specifications given at Annexure "A"
- Low quality item/ brand will not be accepted.
- 70% weight will be given to technical evaluation and 30% to financial evaluation.
- The vendor/ bidder who fulfils all technical requirements, as laid down in the RFP, will be given 100 marks which will be converted into 70 marks for final evaluation. Other bidders will be awarded technical marks with the same ratio.
- 100 technical mark will be calculated as under:
  - a). 50 points/ marks will be given to top quality. 10 points will be decreased for each of the 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> etc level quality.
  - b). 20 points for fulfilling the requirement of specifications;
  - c). 10 points for tax certificate;
  - d). 10 points for authorized dealership certificate.
  - e). 10 points for technical compliance sheets as given in the RFP.
- 30 points/ marks will be awarded to the lowest financial bid. The other bids will be evaluated with the formula: lowest bid x 30/higher bid.

#### 6.13 Delivery Time

Delivery of the laptops and printers should be completed within two weeks after the issuance of SO. Preference will be given to the vendor who, having fulfilled other formalities, will supply the item in short time.
