- Bids for supply and installation of SMD Lights, along with relevant material/ items and removal of old tube lights are to be submitted on Single stage one envelope procedure basis.
- Tender should accompany Earnest Money equal to 2% of the bid (refundable) through Pay Order, Draft, CDR in favor of Competition Commission of Pakistan, Islamabad.
- Earnest Money of unsuccessful bidders will be returned/ refunded after processing of the bids. However, earnest money of successful bidder/ firm will be retained up to completion of warranty period.
- Name/ trade mark and main specifications of the said items should be indicated in the bid clearly.
- Installation charges should be mentioned separately.
- Warranty period should be mentioned clearly.

- Rates without GST will not be considered.
- The successful bidder will be bound to supply and start work of removing old tube lights and installing SMD lights within 15 days of the issuance of supply order.
- The Commission has right to increase or decrease the quantity of lights, ceiling sheets, length of cable, PVC pipe etc.
- Payment of the bill(s) will be subject to the deduction of all mandatory government taxes/levies.
- Submission of false statements/ documents as well as concealing of any information is liable to disqualify the respective firm(s).
- No cutting/overwriting in the offered prices shall be acceptable.
- The successful firm shall not re-submit the revised rates and shall be responsible for supply of the items as per approved prices failing which Security Deposit will be forfeited.
- The Commission has right to reject the bids or proposals at any time prior to acceptance of a bid or proposal, in light of the provisions of Rule 33 (1) of Public Procurement Rules, 2004.
- Only those bids will be considered which will contain offers for the items in accordance with specifications mentioned in the tender notice.
- The proposals containing low quality items will technically be not acceptable.
- The work will be assigned to the vendor(s) whose bid be lowest as a whole, i.e total amount of the bid will be lowest.
