**TENDER NOTICE NO. CCP-ADMIN 76
FOR PROCUREMENT OF INTER ACTIVE FLAT PANEL DISPLAY (IFPD)**

Competition Commission of Pakistan invites sealed bids from authorized dealers/distributors, registered with Tax Department having valid/ active NTN and GST numbers, with relevant experience, to supply/ install Inter Active Flat-Panel Display (IFPD) and its mobile cart (trolley), having following specifications/ features:

- i. CPU: Intel Core i5 7th Generation, 8 GB RAM
- ii. Operating System: Widows 10 Professional Licensed.
- iii. Screen Size: 55/ 60 Inches
- iv. Resolution: 4K UHD (3840 x 2160 @ 60Hz)
- v. Ram: 3 GB
- vi. MIC: Built- in
- vii. Camera: Built-in
- viii. Sound and Speakers: Built-in 2 x 15 Watt Dolby Speakers
- ix. Connectivity: Wireless, Bluetooth, WiFi Dual band (2.4 GHz and 5.0 GHz)
- x. Full access to Android apps and Window OS
- xi. Touch Screen Interactivity

Terms & Conditions]

- Bids for supply of Inter Active Flat-Panel Display (IFPD) are to be submitted on Single stage – one envelope procedure basis.
- Tender should accompany Earnest Money equal to 2% of the bid (refundable) through Pay Order, Draft, CDR etc. in favor of Competition Commission of Pakistan, Islamabad.
- Earnest Money of unsuccessful bidders will be returned/ refunded after processing of the bids. However, earnest money of successful bidder/ firm will be retained up to completion of warranty period.
- Warranty: 3 years for panel. One year for Maintenance and parts.
- Name/ trade mark and features/ Specifications should be indicated in the bid clearly.
- Warranty period should be mentioned clearly.

- The bid should accompany an undertaking on the stamp paper of Rs. 50/- to the effect that the company provides 100% original products; that the company has not been black listed by any government, semi government or autonomous organization; that the company is not under litigation in any court of law or not at any stage of bankruptcy; and it has not supplied the same item(s) to any department organization at the rate(s) lower than offered in this tender during the same financial year.
- The successful vendor will provide maintenance service, after expiry of warranty, at agreed rates, if desired by the CCP.
- Rates without GST will not be considered.
- The bids submitted by those vendors who do not have valid/ active NTN and GST numbers, will be rejected.
- The successful bidder will be bound to supply the Inter Active Flat-Panel Display (IFPD) within 15 days of the issuance of supply order.
- Payment of the bill(s) will be subject to the deduction of all mandatory government taxes/ levies.
- Submission of false statements/ documents as well as concealing of any information is liable to disqualify the respective firm(s).
- No cutting/overwriting in the offered prices shall be acceptable.
- The successful firm shall not re-submit the revised rates and shall be responsible for supply of the IFPD as per approved price, failing which Security Deposit will be forfeited.
- The Commission has right to reject the bids or proposals at any time prior to acceptance of a bid or proposal, in light of the provisions of Rule 33 (1) of Public Procurement Rules, 2004.
- Only those bids will be considered which will contain offers for the IFPD in accordance with terms & conditions mentioned in the tender notice.
- The proposals containing low quality item(s) will technically be not acceptable.
- Procurement contract will be awarded to the vendor whose bid is evaluated as most advantageous in accordance with PPRA Rules. 70% weight will be given to technical evaluation and 30% to financial evaluation. Technical evaluation will be made w.r.t specs. In financial evaluation the lowest offer will be awarded 100 marks. Other bids will be evaluated as per following formula:

(lowest rate x100/ higher rate=points secured). Then the points will be converted into 30% of the secured points.

- All bids should reach the undersigned at the given address up to September 16th 2021 at 1500 hours which will be opened on the same date and venue at 1530 hours in presence of bidders or their authorized representatives.
- On demand of CCP, the bidder(s) will have to demonstrate the IPFD. In case it is found that quality of quoted item is low or that of substandard, the bid will be rejected.
- Bids are to be submitted in accordance with “Bid Format” given below.
