- Pay orders/ Bank Drafts pertaining to security deposit will be returned to unsuccessful bidders after completion of initial processing whereas that of successful bidder(s) will be retained upto satisfactory completion of the work.
- Rates without GST will not be considered.
- The firms should have a minimum of five (05) years experience in supply/ installation of the items for which they are submitting their bids and should have a proper workshop/office at Rawalpindi/ Islamabad.
- Officer (s) of the Commission may visit (if required) the workshops/ offices of bidders to see the quality of items.
- The proposals should not have any over-writing or cutting. Bids with any of the aforementioned defects will not be considered.
- The contract will be awarded to the bidder whose bid(s) contain (s) the items as per requirement.
- The work is required to be completed with in a period of one month from the date of receipt of Work Order. The supplier will be bound to supply/ install the goods of approved quality.
- Only those bids will be included in the list wherein the quoted items will technically be in accordance with the required standard.
- The competent authority may increase/ decrease the number of items or the dimension of area wherein these items are to be installed.
- Payment of the bills will be subject to the deduction of mandatory government taxes/levies.
- Sample may be seen up to 13 March, 2018 during the working days/ hours in the CCP office premises-9th floor (south), ISE Towers, Blue Area, Islamabad.
- Bid documents may be obtained from the undersigned on payment of Rs. 3,000/- in form of pay order, bank draft ect on the name of Competition Commission of Pakistan upto 14 March, 2018.
- Sealed tenders are required to be delivered to the under signed at 9th Floor, ISE Towers, Blue Area, Jinnah Avenue, Islamabad by the 26 March, 2018 upto 1500 hours which will be opened at 1530 on the same date and venue, in presence of the bidders or their authorized representatives.
- The Commission has right to reject all the bids or proposals at any time prior to acceptance of a bid or proposal, in light of the provisions of Rule 33 (1) of Public Procurement Rules, 2004.
