Manual Applications shall not be accepted. Electronic Applications will be opened on the same day at 1530 hours.

2.0 Instruction to Prospective Constructors:

This prequalification of Constructors is only applicable for Package – I: Civil, Electrical & Plumbing Works for the project.

2.1 Introduction:

- 1. Competition Commission of Pakistan (CCP) is an autonomous body established under Section-12 of the Competition Act, 2010 (the Act). It ensures free competition in all spheres of commercial and economic activity to enhance efficiency and to protect consumers from anti-competitive behavior.
- 2. CCP is renting office premises in ISE Towers, 55-B, Jinnah Avenue Islamabad. The Commission has been allocated land by the Capital Development Authority (CDA) measuring 3,017.77 sq. yds. (194' x 140') for the Construction of Office Building, Plot No. 36 & 38, Sector G-10/4, Mauve Area Islamabad.
- 3. The project is aimed to establish office building of Competition Commission of Pakistan, with all services and departments under one roof, on the allocated piece of land measuring 3,017.77 sq. yd. in Sector G-10/4, Mauve Area Islamabad.
- 4. The proposed CCP building was designed with FAR 1:2 & consists of 02 Basement + Ground + 06 Floors. The total construction area is around 109,504 sq. ft. The total superstructure (G+06 floors) is around 54,320 sq. ft. and substructure area (02 basements) are 54,160 sq. ft.
- 5. The Project Management & Detailed Construction Supervision Consultant including the Engineer of the project is Joint Venture M/s. DESIGNMEN Consulting Engineers Pvt. Limited, M/s. Berkeley Associates Pvt. Limited and M/s. Salman Mansur & Associates (JV DCE-BAL-SMA).
- 6. It is also estimated that the works under Package I (Civil, Electrical & Plumbing) is scheduled to be commenced in December 2024.
- 7. Prospective Constructors may submit the complete requirements and requisite documents as solicited in the prequalification applications through Evaluation Criteria, Annexures and Forms including any other mandatory requirements of the Prequalification of Constructors for the Package I: Civil, Electrical & Plumbing Works.

2.2 SUBMISSION OF PREQUALIFICATION APPLICATIONS:

- 1. The application must only be submitted via EPADS (e-Pak Acquisition & Disposal System) at www.eprocure.gov.pk by the interested Constructors.
- 2. Applications for prequalification of constructors for Package I: Civil, Electrical & Plumbing Works, must clearly mention "Application for Prequalification of Constructors for Package I: Civil, Electrical & Plumbing Works for Construction of Office Building of Competition Commission of Pakistan, Plot No. 36 & 38, Sector G-10/4, Mauve Area Islamabad."

(Package – I: Civil, Electrical, Plumbing & Fire Fighting Works)

- 2. Applications must be submitted on or before the deadline outlined this prequalification document via EPADS at www.eprocure.gov.pk.
- 3. The applicants are required to provide complete information in their applications as solicited in the prequalification documents.
- 4. The applicant's omission/ failure in providing requisite information, data and documents may result in disqualification in the pre-qualification process. Further the provision of false, and misleading information and forged documents etc. may also result in disqualification in the prequalification process.

2.3 Language of the Pre-qualification Applications:

- 1. The language of the electronically available prequalification document is English.
- 2. The prequalification applications shall be prepared in English language only. The information in any other language shall be accompanied by its authentic translation in English along with proof/ witness/ health for the authentic translation in accordance with relevant laws of Pakistan having jurisdiction in Islamabad Capital Territory (ICT).

2.4 Complete and Requisite Information:

- 1. Only the required information, documents must be provided precisely in accordance with the format/Forms attached to the prequalification document.
- 2. CCP will not be accountable for disadvantage, if any, caused to the prospective Constructors, on account of incomplete, unclear, ambiguous, unwanted, inaccurate, misleading, false, etc. information and documents etc. provided in the Prequalification Application.

3.0 PREQUALIFICATION CRITERIA:

3.1 General Information:

- 1. Prequalification of applicants will be based on the following criteria.
 - i. Mandatory Prequalification Criteria.
 - ii. Other Qualifying Criteria.
- 2. The submitted applications shall be initially assessed for the Mandatory Prequalification Criteria. Only those applicants who completely fulfilled Mandatory Prequalification Criteria, shall only be eligible for the further evaluation of their applications under Other Qualifying Criteria.
- 3. The applications of those applicants who partially fulfilling Mandatory Prequalification Criteria or completely fail to fulfil Mandatory Prequalification Criteria, shall be rejected, and marked as **disqualified** in the prequalification process. Such applicants shall not take part further in the procurement process.
- 4. The prequalification status shall be decided based on Pass/ Fail. Only those applications of applicants will be considered as **Prequalified** in the Prequalification Process, who completely fulfil following criteria.
- (i) Completely fulfil with Mandatory Prequalification Criteria, and
- (ii) Obtained minimum 50% marks in each category of Other Qualifying Criteria, and
- (iii) Obtained overall minimum marks 70% or above in Other Qualifying Criteria.
- 5. Subcontractor's experience and resources (personal, equipment and financial soundness etc.) shall not be considered in determining the Applicant's compliance with the other qualifying Criteria.
