- The tender should accompany a Pay Order/ Bank Draft equal to 2% of the bid value in favor of Competition Commission of Pakistan, Islamabad as earnest money. The same will be returned to unsuccessful bidders after completing the formal procedure and to successful bidder after completion of the job.
- All bids must include the amounts of GST and all other taxes.
- The bidders should have their own printing press. They should also have art/creative department and proof reading facilities.
- Specimen material for printing may be seen in the office of under signed during working days from 10:00 a.m to 4:00 p.m.
- Best sample of Annual Report, Act or similar publication(s) must accompany the bids.
- The Commission reserves the right to send any authorized person(s) to visit site of the printer to check whether the printing firm has all the facilities to meet requirements of the printing material.
- The successful firm will be bound to print/supply all the books within one month of the date of supply order.

- The tenders should reach the undersigned by the 15th March, 2016 upto 03:00 p.m which will be opened on the same day at 3.30 p.m, in presence of bidders or their authorized representatives.
- The Competent Authority has right to reduce or increase the quantity of printing items. similarly the Commission has right to reject the bids or proposals at any time prior to acceptance of a bid or proposal, in light of the provisions of Rule 33 (1) of Public Procurement Rules, 2004.
