FOR PROCUREMENT OF MOBILE PHONE SETS**

Competition Commission of Pakistan invites sealed bids from authorized dealers/distributors, registered with Tax Department having valid/ active NTN and GST numbers, with relevant experience, to supply 5 to 8 sets of mobile phones of following variety:

- i. Samsung Galaxy S 10 or equivalent
- ii. Apple i phone X or equivalent

Terms & Conditions

- The mobile sets must be registered with the PTA.
- The mobile sets may be purchased from one or more than one vendors.
- Warranty period should be mentioned in the bid clearly.
- The Commission may increase or decrease the quantity of mobile sets.
- Tender should accompany Earnest Money equal to 2% of the bid (refundable) through Pay Order, Draft etc. in favor of Competition Commission of Pakistan, Islamabad.
- Earnest Money of unsuccessful bidders will be returned/ refunded after initial processing of the bids. However, earnest money of successful bidder/ firm will be retained up to expiry of warranty period.
- Specifications of the both varieties should be mentioned in the bid clearly.
- Rates without GST will not be considered.
- Proposals for low quality mobile sets will not be accepted.
- Evaluation of the bids will be made under the PPRA Rules
- The successful bidder (s) will be bound to supply the said item within 15 days of the supply order.
- Payment of the bill will be subject to the deduction of all mandatory government taxes/ levies.
- Submission of false statements/ documents as well as concealing of any information is liable to disqualify the respective vendor.

- No cutting/overwriting in the offered prices shall be acceptable.
- The successful vendor shall not re-submit revised rates and shall be responsible for supply of the mobile sets as per approved price(s) failing which Security Deposit will be forfeited.
- The Commission has right to reject the bids or proposals at any time prior to acceptance of a bid or proposal, in light of the provisions of Rule 33 (1) of Public Procurement Rules, 2004.
- All bids should reach the undersigned at the given address by the 20th May, 2019 up to 11:00 a.m which will be opened on the same date and venue at 11:30 a.m in presence of bidders or their authorized representatives.
