Terms & Conditions

- Tender for renewal of licenses for above mentioned five softwares for a period of one year should accompany Earnest Money equal to 2% of the bid (refundable) through any mode of payment - Pay Order, Draft etc. in favor of Competition Commission of Pakistan, Islamabad.
- Earnest Money of unsuccessful bidders will be returned/ refunded after processing of the bids. However, earnest money of successful bidder/ firm will be retained up to expiry of the licenses.
- The bidders should have their offices, branches, shops etc. in Islamabad/ Rawalpindi. Clear address with phone(s), fax numbers must be written on the letterhead pads of the bidders on which bid is being made.

- Rates should be included GST. Without GST no rate will be considered.

- The successful bidder will be bound to supply the required license(s) within 15 days of the supply order.
