Candidate with LLM or Bar-at-Law or Ph.D. degree in the relevant discipline will be given preference.</p> <p>(ii) The candidate must have a minimum of 7 years of professional experience preferably in competition law & policy and/or regulatory affairs, including at least 2-3 years in a leadership or managerial role.</p> <p><u>Professional Credentials:</u></p> <p>Ideal candidate should have a strong understanding of competition law and economic principles, along with excellent analytical and communication skills. The candidate should demonstrate the ability to interpret and apply complex legal and economic concepts within a regulatory framework. The role requires the capacity to analyze market structures, and conduct of businesses, identify and assess potential anti-competitive behavior, and lead effective enforcement under competition law. Substantial professional experience in competition law enforcement, regulatory affairs, legal or economic analysis, or market investigations, will be given strong preference.</p> <p><u>Key Responsibilities:</u></p> <p>(i) Lead, supervise, and manage enforcement activities in accordance with the Competition Act, 2010 and relevant regulations.</p> <p>(ii) Conduct and supervise the investigation of anti-competitive practices, including abuse of dominance, cartelization, bid rigging, and deceptive marketing practices.</p> <p>(iii) Review and provide guidance on the preparation of inquiry reports, and enforcement orders.</p> <p>(iv) Conduct market studies and research work related to competition enforcement.</p> <p>(v) Coordinate with other relevant departments to ensure comprehensive enforcement outcomes.</p> <p>(vi) Stay abreast of international best practices and propose policy improvements to strengthen enforcement mechanisms.</p> <p>(vii) Perform any other duties as assigned by the senior management in furtherance of the Commission's objectives.</p>
