- 1. Tender/ Bid should be accompanied with a Bid Security equal to two percent of the total Bid Price payable in the form of Pay Order/Bank Draft/Cross cheque in favour of "Competition Commission of Pakistan" Islamabad.
- Bid Security of unsuccessful bidders will be returned/refunded after the opening of tenders.
 However, Bid Security of successful firm(s) will be returned after successful completion of supply order.
- 3. Sample of uniform can be seen in the office of the undersigned. All liveries shall be supplied according to the sample and approved fabric with approved stitching pattern etc.
- 4. Bids are required to be submitted with sample of cloth/fabric and samples for stitching patterns.
- 5. All Rates/ Prices of bids shall be included with GST applicable.
- 6. The "Most Advantageous Bid" shall be the bid having strictly compliance with the complete terms and conditions of the bid and shall have the total lowest cost of the bid (Least cost method). The supply order shall be issued to the bidder submitted most advantageous bid and such bidder is called the successful bidder.
- 7. The payments are made according to the works executed as per Bill of Quantities.
- 8. Payments of the invoices/ bills shall be subject to the deduction of income tax, GST/ Government Taxes/levies.
- 9. CCP reserves the right to appoint the authorized person(s) for visiting & checking the place of stitching of the work etc. and provide instructions/ advice accordingly in writing.
- 10. CCP having right to increase or decrease the quantity provided in Bill of Quantities, similarly, having right to add/ omit/ change any items in Bill of Quantities.
- 11. CCP having right to reject all tenders/bids without assigning any reason(s) thereof.
- 12. The successful bidder shall be bound to supply all items of Liveries in stitched form within a period of thirty (30) days from the date of the supply order.
- 13. The payments of bills/ invoices shall be made to such supplies of approved liveries as per Bill of Quantities in accordance with instructions and complete checking of the fabric and stitching as per approved sample.
- 14. All bids should reach the office of the undersigned by 15th December 2022 up to 2:30 p.m. which will be opened on 3:30 p.m. in the presence of the Bidders or their authorized representatives.
