The Competition Commission of Pakistan (CCP), an autonomous regulatory authority is seeking a highly experienced professional to take on the role of **Senior Market Specialist** (one-position) on a contract basis for an initial period of two years.

Key Responsibilities:

- a. Lead and oversee complex investigations related to anti-competitive practices, mergers, cartels, abuse of dominant position, and other market-related issues.
- b. Provide strategic direction, ensuring high-quality research, data collection, and evidence analysis to support competition enforcement.
- c. Collaborate with internal teams and external stakeholders to ensure thorough and timely investigations of market dynamics
- d. Develop and implement effective investigation procedures, ensuring compliance with national and international best practices.
- e. Provide concise and timely reports, insights, and strategic recommendations to senior management based on detailed market research and intelligence.
- f. Stay updated on global market trends, competition laws, and economic factors impacting competition within Pakistan.

Academic Qualifications and Requirements:

- a. Master's degree in Economics, Law, Statistics, Accountancy, Business Administration, Market Research, or a related field from HEC recognized local or foreign university.
- b. A minimum of 15 years of experience in competition law enforcement, regulatory investigations, or market research.
- c. Proven leadership and team management skills with experience in handling complex market investigations.
- d. Strong analytical skills, with expertise in interpreting market data and economic trends.
- e. Excellent communication and report-writing abilities, with a focus on presenting findings to senior management.
- f. Comprehensive knowledge of competition laws, market dynamics, and experience in managing regulatory affairs.
- g. Investigative/Analytical skills attained from NAB/Police and FIA may be given preference.
- h. Candidates having experience with other regulatory bodies may be given preference.
- i. Max age limit for the position is 50 years, including general age relaxation.
