Office has raised objection that
appeal is barred by time. Learned counsel
for the appellant without disputing the
office objection contends that the appellant
being the president of Dairy Farmer
Association Karachi and was appearing
before the Commission in that Capacity,
however, the commission after hearing the
matter instead of imposing penalty on
Association had imposed penalty on the
appellant. The appellant could not
apprehend the complexity of the situation
filed appeal within statutory period but in
the name of Dairy Farmer Association
Karachi instead of his personal name.
When the matter was taken up the counsel
appearing realized his mistake and
consequently withdrew the appeal to file a
fresh in the name of the appellant, the
President of the Association and this
process has taken time which has made the
instant appeal bared by time. Counsel
prays that in other two appeals filed
challenging the instant impugned order
