Appellant had been doing business since long in the market and selling packing materials as per requirements of shop keepers of market. Appellant is not involved in manufacturing or imports.



JUDGMENT

Mazhar Alam Khan Miankhel, Chairperson: -

Neither the appellant nor his Counsel is in attendance.
This appeal is against the order dated 27.08.2018, passed by the
Competition Commission of Pakistan (the Commission).

2. We have noticed that Memorandum of Appeal was received
^{The} by office through 'Tranzum Courier Service' (TCS) but there were
certain deficiencies. The office of the Tribunal was repeatedly
issuing notices to the appellant as well as the learned Counsel to
make up the deficiencies and the first notice in this regard available
on file is dated 20.12.2018, but no such compliance till date has
been made. On the last date of hearing there was an application for
adjournment received through Courier but today no one is before
the court to represent the appellant. We are satisfied qua the



conduct and behavior of the appellant which reflects that he has lost interest in pursuing his appeal. Neither the penalty amount has been paid nor the deficiencies notified to him have been removed.

3. In these circumstances, we are left with no other option but to dismiss the appeal under sub Rule 3 of Rule 8 of the Competition Appellate Tribunal Rules, 2015.
