RENEWED EXEMPTION CERTIFICATE

In pursuance of the powers conferred by Section 5 read with Section 9 of the Competition Act, 2010 (the Act), the Competition Commission of Pakistan (the Commission) hereby grants exemption from the application of Section 4 of the Act, details whereof are given here below:-

DETAILS OF THE AGREEMENT

First Party: M/s. Eli Lilly Pakistan (Private) Limited ('Lilly')

Second Party: M/s. AGC (Private) Limited ('AGC')
Business address: State Life Building, 1- B, I.I. Chundrigar Road, Karachi.

Type of Agreement: Service Agreement

Date entered into: January 1st, 2016 & December 31st 2019 (through 6th Amendment)

Valid until: December 31st 2021

DETAILS OF THE EXEMPTION

Exemption granted to: Territorial Exclusivity clause(s) of the agreement

Granted until: 31-12-2021

Condition(s):

- i. The Exemption certificate, shall in no way be construed as an approval for fixation or maintaining 'Minimum Retail Price' with reference to the products' subject matter of the Service Agreement;
- ii. This exemption is effective only for the territory of Pakistan;
- iii. The Applicant shall intimate to the Commission in case of any amendment(s) made to the Service Agreement;
- iv. The Applicant shall also provide copy(s) of any other agreement(s) of similar nature apart from the Agreement, once executed;
- v. The Commission reserves the right to impose any condition(s) at the time of considering extension, if any; and
- vi. Breach of a condition shall have the effect of cancellation of the exemption.

Without prejudice to the generality of Section 6 of the Act, the grantee of the exemption shall inform the Commission forthwith and seek clearance for continuation of the exemption if there is any material change, *inter alia*, in: (i) the terms of the agreement; (ii) the market share of the parties to the agreement; or (iii) the circumstances in the market in which the parties are operating.
