Condition(s):

- i. The Applicant shall provide copy of the 'Future Agreement' to the Commission, once executed;
- ii. The Exemption is effective only for the products mentioned in the provided List;
- iii. The Applicant shall intimate to the Commission in case of any amendment(s) made to the Agreement;
- iv. The Applicant shall provide copy(s) any other agreement(s), apart from the Agreement;
- v. The Commission reserves the right to impose any condition(s) at the time of considering extension, if any; and
- vi. Breach of a condition shall have the effect of cancellation of the exemption.

Without prejudice to the generality of Section 6 of the Act, the grantee of the exemption shall inform the Commission forthwith and seek clearance for continuation of the exemption if there is any material change, *inter alia*, in: (i) the terms of the agreement; (ii) the market share of the parties to the agreement; or (iii) the circumstances in the market in which the parties are operating.
