RENEWED EXEMPTION CERTIFICATE

In pursuance of the powers conferred by Section 5 read with Section 9 of the Competition Act, 2010 (the Act), the Competition Commission of Pakistan (the Commission) hereby grants exemption to the template agreements from the application of Section 4 of the Act, details whereof are given here below:-

DETAILS OF THE AGREEMENT

First Party: M/s. Reckitt Benckiser Pakistan Limited (hereinafter referred to as the 'Company')
Business address: Tenancy 04 & 05, 3rd Floor, Corporate Office Block, Dolmen City Mall, HC – 3, Block 4, Scheme 5, Clifton, Karachi.

Second Party: Standard Distributorship Agreement executed with 41 distributors

Type of agreement: Standard Distributorship Agreement

Date entered into: Different dates with different distributors

Valid until: For an indefinite period – Unless terminated by either party

DETAILS OF THE EXEMPTION

Exemption granted to: Non-Compete and Territorial Exclusivity clauses of the Agreement

Granted until: 31-03-2023

Condition(s):

- i. The Exemption certificate, shall in no way be construed as an approval for fixation or maintaining 'Minimum Retail Price' with reference to the products' subject matter of the Standard Distributorship Agreement;
- ii. This exemption is effective only for the territory of Pakistan;
- iii. The Applicant shall intimate to the Commission in case of any amendments made to the Standard Distributorship Agreement;
- iv. The Applicant shall also provide copy(s) of any other agreement(s) of similar nature apart from the Agreement, once executed;
- v. The Commission reserves the right to impose any condition(s) at the time of considering extension, if any; and
- vi. Breach of a condition shall have the effect of cancellation of the exemption.

Without prejudice to the generality of Section 6 of the Act, the grantee of the exemption shall inform the Commission forthwith and seek clearance for continuation of the exemption if there is any material change, *inter alia*, in: (i) the terms of the agreement; (ii) the market share of the parties to the agreement; or (iii) the circumstances in the market in which the parties are operating.
