Granted until: 15-04-2024

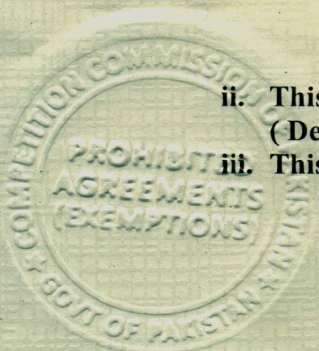
Condition(s):

i. This Applicant shall not be involved directly or indirectly in any abusive practice (s) and/or conduct(s), as envisaged under Section 3 of the Competition Act, 2010, including but not limited to:

- i. Unfair trading conditions
- ii. Tie ins
- iii. Boycotting and
- iv. Exclusionary conduct

ii. This exemption is effective only for the Product(s) defined under Article – I (Definitions and Rules of Interpretation) of the Agreement;

iii. This exemption is effective only for the territory of Pakistan;



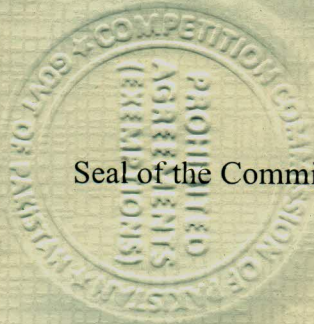

- iv. The Applicant shall also provide copy(s) of any other agreement(s) of similar nature apart from the Fuel Supply Agreement, once executed;
- v. The Applicant shall intimate to the Commission in case of any amendments made to the Agreement;
- vi. The Commission reserves the right to impose any condition(s) at the time of considering extension, if any; and
- vii. Breach of a condition shall have the effect of cancellation of the exemption.

Without prejudice to the generality of Section 6 of the Act, the grantee of the exemption shall inform the Commission forthwith and seek clearance for continuation of the exemption if there is any material change, *inter alia*, in: (i) the terms of the agreement; (ii) the market share of the parties to the agreement; or (iii) the circumstances in the market in which the parties are operating.
