Global Competition Review shortlists CCP for Agency of the Year Award

ISLAMABAD: The Global Competition Review (GCR) has shortlisted the Competition Commission of Pakistan (CCP) in the category of 'Agency of the Year Award' for Asia-Pacific, Middle East and Africa region.

A CCP statement issued on Thursday said that it has also been nominated in the category of "Behavioral Matter of the Year" - Asia-Pacific, Middle East and Africa region for its decision to grant leniency to Siemens in the case of collusive bidding by members of the Pakistan Electrical Power Equipment Manufacturers Association (PEMA).

The London-based Global Competition Review is a leading international anti-trust and competition law journal and is widely consulted by the competition authorities, lawyers and academicians.

The awards aim at recognising the achievements of teams and individuals from private practice firms, academic organisations and competition authorities in 2012.

Around 140 nominations are gathered by the GCR with the winners being decided by votes cast by GCR readers, the statement said

CCP Chairperson Rahat Kaunain said that the decision is a major victory for the commission as it not only reflects confidence in the agency but also reflects establishment of its writ, which has been under attack since its inception.

The chairperson said that even in the developed countries such as the United States and the European Union (EU) nations, leniency applications were not filed as swiftly as in this case after drafting of the respective regulations
